CONTRACT AGREEMENT

This Agreement, made this 10th day of December, 2019 between Metro Vigan Water District (hereinafter called "the Entity") and RAMSA Construction and Supply (hereinafter called "the Contractor") of the other part.

Whereas, the Entity is desirous that the Contractor execute Construction of Metro Vigan Water District Office Building Extension at P. Burgos St., Solid West, Vigan City (hereinafter called "the Works") and the Entity has accepted the Bid for SEVEN MILLION SEVEN HUNDRED FORTY FIVE THOUSAND SEVEN HUNDRED NINETY PESOS AND 74/100 CENTAVOS (Php 7,745,790.74) by the contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Assignment, to wit:
 - a) General and Special Conditions of Contracts;
 - b) Drawings/Plans;
 - c) Specifications;
 - d) Invitation to Bid;
 - e) Instructions to Bidders;
 - f) Bid Data Sheet;
 - g) Addends and/or Supplemental/Bid Bulletins, if any;
 - h) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes;
 - i) Eligibility requirements, documents and/or statements;
 - j) Performance Security;
 - k) Notice of Award of Contract and Bidder's conforme thereto;
 - l) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the contractor as hereinafter mentioned, the contractor hereby convents with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of the Contract in all respects.
4. The Entity hereby covenants to pay the contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.

IN WITNESS whereof the parties thereto have caused this Agreement to be executed the day and year first before written.




